

President Donald J. Trump Unleashes American Commercial Fishing in the Paci

QUOTE: UNLEASHING OPPORTUNITY IN THE PACIFIC: Thursday, President Dona Trump signed a proclamation to unleash American commercial fishing in the Pac Ocean—a key component of the America First Fishing Policy.

- The proclamation opens the Pacific Remote Islands Marine National Monumen (PRIMNM) to commercial fishing, boosting the economy of American Samoa.
- It allows U.S.-flagged vessels to fish commercially within 50 to 200 nautical mile of the PRIMNM's boundaries.

EMPOWERING AMERICAN COMMERCIAL FISHERMEN: President Trump believes that removing unnecessary restrictions on American fishermen will strengthen th U.S. economy, support local communities, and restore fairness to an industry disadvantaged by overregulation and foreign competition.

• The PRIMNM was first established by President Bush in 2009 and then expande by President Obama, closing off over 400,000 square miles of the U.S. Exclusive Economic Zone in the Pacific.

- The ban on commercial fishing within the PRIMNM did little to guard fish populations against overfishing, as tuna and other pelagic species are migratory nature and do not permanently reside within the PRIMNM.
- As a result of the prohibitions on commercial fishing, American fishing fleets half of the United States' Exclusive Economic Zone in the Palslands.
- This has driven American fishermen to fish further offshore in international wat to compete against poorly regulated and highly subsidized foreign fleets, most notably from China.
- By supporting honest American fishermen, we combat the rampant illegal, unreported, and unregulated fishing by foreign fleets.
- This disadvantages United States commercial fishermen and is detrimental for United States territories like American Samoa, whose private sector economy is dependent on the fishing industry.
- American Samoa is home to the only Buy American-compliant tuna processing facility for U.S. military rations and school lunch programs.
- This cannery is the largest employer on the island, providing about 5,000 jobs. fact, the cannery accounts for 99.5% of American Samoa's exports and 84% of th private employment in the territory.

The AMA's Federally-Funded Cash Cow Fuels Their Woke Agenda

White House Rips Fauci in Revamped COVID-19 Website Detailing Virus's 'True Origins'

QUOTE: The White House has revamped the COVID-19 guidance page, which no states the likely origin of the virus was a lab leak involving gain-of-function research.

The website features the heading "Lab Leak," with a subheading of "The True Origins of COVID-19." The White House lists five key points regarding the coronavirus's genesis:

- "The virus posses a biological characteristic that is not found in nature."
- "Data shows that all COVID-19 cases stem from a single introduction into huma This runs contrary to previous pandemics where there were multiple spillover events."
- "Wuhan is home to China's foremost SARS research lab, which has a history of conducting gain-of-function research (gene altering and organism supercharging at inadequate biosafety levels."
- "Wuhan Institute of Virology (WIV) researchers were sick with COVID-like symptoms in the fall of 2019, months before COVID-19 was discovered at the we market."
- "By nearly all measures of science, if there was evidence of a natural origin it would have already surfaced. But it hasn't." [emphases original]

The website also challenges "The Proximal Origin of SARS-CoV-2" publication, which asserted that the virus originated organically.

"The Proximal Origin of SARS-CoV-2' publication — which was used repeatedly public health officials and the media to discredit the lab leak theory — was prompted by Dr. Fauci to push the preferred narrative that COVID-19 originated nature," the website states.

The likely cause of the virus, per the White House, was a lab leak during gain-of-function research.

"A lab-related incident involving gain-of-function research is the most likely the origin of COVID-19. Current government mechanisms for overseeing this danger gain-of-function research are incomplete, severely convoluted, and lack global applicability," the page notes. The White House sourced the information for the page from the House Oversight Committee website.

Not just at Easter: Gen Z is returning to Christianity. Data proves it.

QUOTE: It's not time to call this a revival, but something is stirring in the culture. Christians would do well to pay attention, live out their faith and step into the opportunity to share with others.

Religious data rarely makes headlines, but a new wave of findings is creating a st

For three decades, the percentage of Americans who identify as Christian has steadily declined, a trend confirmed by countless studies. For many believers, it he felt like an inevitable slide into cultural irrelevance. In a season of overwhelmed news cycles, these religious shifts haven't received the coverage they should, but they are significant, and they keep coming.

The dominant religious storyline in recent decades has been the rise of the "none" those who mark "none" for religious affiliation. Secularism pulls down religious commitment like gravity pulling down a satellite. Over time, the orbit decays unt there is a crash.

Christianity in the United States has followed a similar trajectory, declining about 1% per year. It looked almost inevitable that a crash was looming. But now, something is shifting. And we can see it in the data among Generation Z, those born between 1997 and 2012.

Perhaps most surprisingly, Gen Z men are now more likely to attend church than Gen Z women. The New York Times reported that among young Christians, men staying in church (at the same time, many women are leaving).

Overall, younger generations are more spiritually curious. Barna research group reports that most Gen Z teens are interested in learning more about Jesus, with younger cohorts leading the way in the growth of new commitments.

Americans' engagement with the Bible also appears to be increasing. The 2025 State of the Bible report from the American Bible Society found an increase in Bil use and engagement.

According to The Wall Street Journal, Bible sales have spiked, driven largely by fit time buyers.

Finally, Christian entertainment has seen a remarkable surge. From "The Chosen" "The King of Kings," faith-based storytelling is gaining a wider audience.
